11. In requesting SCCA Solo sanctions, the organizing region certifies that this event will be organized and conducted in accordance with the mandatory portions of the Solo rules.

Solo audit form must be completed & returned to SCCA Solo Dept. along with the appropriate sanction fee & insurance fee no later than 45 days after the event. Sanction fee is \$3.75 per driver; insurance fee is \$5.00 per driver (insurance minimum: 20 drivers/\$100).

For audits not paid within 90 days of the event, the region will be invoiced for a fee determined by adding the number of drivers competing in your region in 2006, dividing by the total fee determined by number of events for the year, and then adding an additional 50% to that amount. In the event of a cancellation, written notification is required no later than 2 weeks after the scheduled event. If written notification is not received within this time, the host region will be charged for the event.
